FBLA Dues: \$13 (\$6 national and \$7 state)

ML Dues: \$11 (\$6 national and \$5 state)

(Local dues are at the discretion of the local chapter)

Paying Dues

Pay or Renew dues online at www.fbla-pbl.org. If a credit card is not used at the time members are entered, an invoice will be sent to the school for payment with a check. Paid state dues must be on record with the national office no later than January 25th to be eligible to compete at both the ML and HS State Leadership Conference and/or run for state office. All outstanding invoices must be PAID to the national office by March 1 for students to compete at the National Leadership Conference.
