#### Important Information (Overview)

#### **Membership Dues**

All Divisions (HS, MS, Collegiate) \$20 (\$10 national and \$10 state); Local dues are at the discretion of the local chapter.

#### **NOTE**

A chapter must have a separate Middle-Level charter to be able to pay ML dues for Grades 5-8 members (Grade 9 for members in specified junior high building). Members must be part of a ML chapter to compete at the ML SLC.

#### **Registering Members and Paying Dues**

Register members and pay or renew dues online at FBLA Connect. If a credit card is not used at the time members are entered, an option will be available to have an invoice sent to the school for payment with a check. Please make sure you receive confirmation of this. Paid state/national dues must be on record with the national office for students to participate in programming (including the BAAs) and no later than January 31st to be eligible to compete at both the ML and HS State Leadership Conference and/or run for state office. All outstanding invoices must be PAID to the national office by March 1st for students to compete at the National Leadership Conference.

#### **New or Reactivating Chapters**

#### **Ohio FBLA Competitive Event Handbook (CEG)**

This Competitive Event Handbook for FBLA and FBLA Middle Level will be available on the Ohio FBLA website with all competitive event updates by mid-September. NOTE: These are the guidelines that will be used for the FBLA State Leadership Conferences. These guidelines should be shared with members as they prepare for the state competition in February. Do you know of any students who want to join but do not have a chapter at their school? No problem! Students may join their division's Virtual Chapter to stay engaged in the program, gain access to all of our educational opportunities, and attend our State Leadership Conference. Ohio FBLA is committed to providing a compelling value for our Virtual Members. Our dedicated Virtual Chapter advisers will keep students connected to all of our offerings while working with them to start a chapter at their school.

#### **Key Players**

Please identify two chapter representatives to serve as Key Players (ideally a Sophomore or Junior). Our Key Players get hands-on leadership experience as well as provide critical student feedback on our programs. Each chapter should designate two (2) liaisons between the State Officer Team and the Local Chapter. Please email Arshya Maricar at president@ohiofbla.org with the student's Name, School Name, Grade, and Email Address to receive further information.

#### **Chapter Registration Information**

If you have not activated your chapter with National FBLA and entered students in the membership system, you must do that ASAP in order to make sure they are processed andable to take advantage of all resources and programming.

#### Membership Portal!

Returning chapter advisers should have access to FBLA Connect. New advisers will receive an invitation to FBLA Connect once chartered. This is our membership portal and it should make chapter management much easier with streamlined processes and one-stop sourcing for your member's needs. If you haven't logged into FBLA Connect this year, please do so as soon as possible. Your chapter's account will likely need some attention to fully benefit from the new system. There are plenty of training resources available and listed in the Ohio FBLA new school year kick-off email.

Highlights of the FBLA Connect portal powered by GreekTrack include advisers being able to view students in alphabetical order by last name, first name on your Transition Member page. To see the alphabetized list, go to the "Members" tab; click on "Transition Members." Also, students now have immediate access to programming if their dues are being paid by check. Previously, if the invoice was paid by check, students would not become active until the National Center processed the check. There are now three options to pay for invoices: Credit Card (which is preferred), Purchase Order, and "Payment by Mail." For invoices paid by mail or purchase order, payment must be received at the National Center within 60 days of the invoice. If payment is not received, the invoice reverts the student back to unpaid status, and the student is not eligible to participate in FBLA programming.

#### **HS Chapter Recognition**

Your chapter is eligible for membership achievement awards and may also enter any of the local chapter events at the SLC. Chapter events include American Enterprise Project, Battle of the Chapters, Community Service Project, Local Chapter Annual Business Report, Spelling Bee and Largest Chapter.

Champion Chapter is a series of membership engagement-focused challenges that chapters may complete for national recognition. By completing activities, chapters accrue points. Completing activities across four sections (to accrue points) will result in Champion Chapter recognition, with a banner for the adviser's classroom/meeting space or school award case. Additional incentives such as ribbons at conferences, national recognition in publications, and plaques are available. Levels include Summer Starter, Shaping Success, Service Season and CTE Celebration. Please pay attention to quarterly deadlines.

#### **HS Individual Recognition**

The easiest way for your HS members to become engaged members is to get them registered, paid and working on individual recognition. Please get them started immediatelyon the Business Achievement Awards. Access to the BAAs is through the FBLA Connect portal. Students that began the BAAs last year may pick up where they left off. Ohio FBLA will supplement this program for students seeking to complete all four levels with the Ohio Achievement Accelerator program. Students that have started the Capstone Level should contact State Adviser, Eric McGarvey for details.

Students may also begin mapping out their plans to compete individually and in team events at the State Leadership Conference being held in February. The national competitive events page has resources to help students choose their events. In Ohio, members may participate in up to five pre-judged or objective test events plus one live or performance events. This is in addition to presenting any chapter events (see above). More information on Ohio FBLA competitive events will be included in the Competitive Events Guide released mid September.

#### **SLC Registration Process & Platform Access**

OH FBLA chapters now use two online platforms for chapter management:

- <u>CONNECT</u> for membership registration, chapter management, student virtual programming, and more.
- Blue Panda for conference registration including competitive events and lodging

   advisers should be able to login to BP with their CONNECT login credentials by clicking the "Login with FBLA CONNECT" box.

These two systems communicate. Once members are shown as 'payment in process' or paid in CONNECT, they will populate in Blue Panda so they may be registered for conference. Paid dues must be on record with the national office for students to participate in programming (including the BAAs) and no later than January 30th to be eligible to compete at SLC and/or run for state office.

NOTE: Non-competing attendees are welcome to register after the Late Registration Deadline based on room availability, including students who may still compete in Open Events.

#### **Competitive Event Resources**

- Ohio FBLA Competitive Events Guide (CEG) Released at approximately the same time as this document, the CEG is the official state awards program and competitive event regulations document. #### DRESS CODE

Projecting a professional image is vital for business leaders to demonstrate respect for clients, colleagues, and others. - Neckwear such as tie or scarf
- Dress shoes (or) dress boots

#### Blazer

- Dress pants, including khakis, (or) dress (or) skirt
- Blazer
- Blouse (or) collared dress shirt
- Neckwear such as tie or scarf
- Dress shoes (or) dress boots

#### Dress

- A business dress
- Dress shoes (or) dress boots

#### Other Professional

- Dress pants, including khakis, (or) skirt
- Blouse (or) collared dress shirt
- Neckwear such as tie or scarf
- Dress shoes (or) dress boots

#### **BUSINESS CASUAL**

- Dress pants, skirt, (or) khakis/chino-style pants
- Blouse, collared dress shirt, (or) polo shirt
- Dress shoes (or) dress boots

NOTE: Business Casual is only permitted during sessions specifically noted in conference materials.

#### **UNACCEPTABLE ITEMS**

The following items are prohibited in all conference areas, including competitive events.



- Denim or flannel clothing
- Shorts
- Athletic clothing
- Leggings or graphically designed hosiery/tights
- Skintight or revealing clothing, including tank tops, spaghetti straps, and mini/short skirts or dresses more than 1" above the knee
- Swimwear
- Flip flops or casual sandals
- Athletic shoes
- Industrial work shoes
- Hiking boots
- Hats
- Graphically printed clothing

No dress code can cover all contingencies, so FBLA members must use a certain amount of judgment in their choice of clothing to wear. Members who experience uncertainty about unacceptable attire should ask their local adviser, state leader, or conference staff.

FBLA recognizes that exceptions may need to be made and will work with advisers on a case-by-case basis to accommodate requests.

Advisers should indicate the need for exceptions on the special accommodation portion of the registration form. Requests made after registration closes must be made in writing.


